### MSC (LX) VS BENCHMARK<sup>(1)</sup>



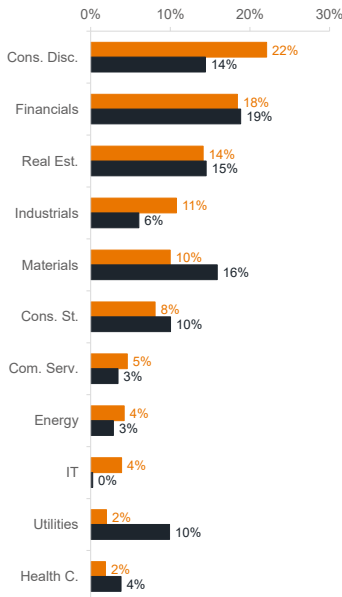

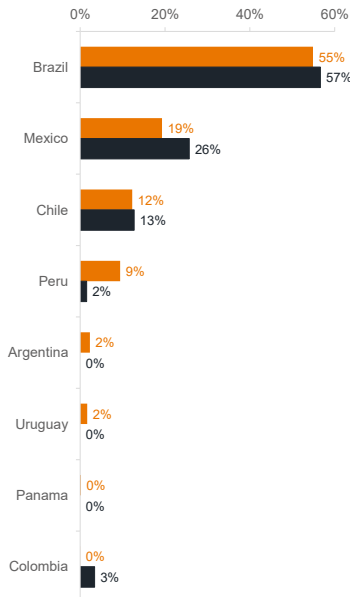
